May 1, 2021, Virtual State Meeting

PROCEEDINGS

State Deputy George Martin welcomes everyone to the Annual Meeting of the Louisiana State Council, and I now declare this meeting to order. As we open this virtual meeting, I would like to ask our State Chaplain Father Jamin David to open with a prayer.

Father David led us in prayer. "O Mary, you always brighten our path as a sign of salvation and of hope. We entrust ourselves to you, Health of the Sick, who, at the Cross, took part in Jesus' pain while remaining steadfast in faith.

O loving Mother, you know what we need, and we are confident you will provide for us as at Cana in Galilee. Intercede for us with your Son Jesus, the Divine Physician, for those who have fallen ill, for those who are vulnerable, and for those who have died. Intercede also for those charged with protecting the health and safety of others and for those who are tending to the sick and seeking a cure.

Help us, O Mother of Divine Love, to conform to the will of the Father and to do as we are told by Jesus, who took upon himself our sufferings and carried our sorrows, so as to lead us, through the Cross, to the glory of the Resurrection. Amen.

Under thy protection we seek refuge, O Holy Mother of God. In our needs, despise not our petitions, but deliver us always from all dangers, O glorious and blessed Virgin. Amen."

State Deputy Duffour thanked Father.

Brother Duffour then called on the Master for the Jurisdiction of Louisiana, Kell Luke, to lead our delegation in the Pledge of Allegiance.

Master Luke then recited the Pledge of Allegiance.

State Deputy Martin then extended his appreciation to the Master.

Brother Duffour then proceeded to make the following announcements:

- 1. Only delegates with proper credentials, have the right to speak during this meeting. This is the same as "floor rights" during a typical meeting. If someone with the right to speak wishes to do so, please utilize the Hand Raise Feature, and you will be placed in the queue. Note that you may be contacted so that we may know your intention to alert me when to recognize you.
 - 2. Presentation on Hand Raise Feature by Bret Cormier
- 3. Please keep your computer or phone muted until called upon to speak or the meeting is open to a motion vote. This will speed up the process of the meeting.
- 4. The Minutes of the 2020 State Convention, and all Reports of Committees, Reports of Officers, Resolutions and the Budget for the next fraternal year have been distributed prior to this meeting (and posted on the state Council website) for review.

Our goal is to complete the required business within 120 minutes, so many items will be abbreviated, or eliminated. I ask that everyone, especially Delegates, stay connected until we have concluded the Meeting.

If you are dropped from the Virtual Meeting, please rejoin by using the link provided to you for the Go-To-Webinar or the call in by phone by dialing 1 (213) 929-4232 with Access Code: 571-939-084.

Due to the circumstances of this virtual State Meeting, I have asked our State Secretary and State Treasurer to serve as our Credentials Committee.

I have also appointed Brother Mark Carver to serve as our parliamentarian for this virtual meeting. Before we begin with the proceedings of our Virtual State Meeting, we will be addressed by our Supreme Knight, Patrick Kelly. Please be attentive to his important message.

A video presentation of Supreme Knight Patrick Kelly was played for all attendees.

State Deputy Martin then introduced Supreme Board Member Rennan Duffour, and thanked him for his participating in our meeting today, and at this time I call on him for his message.

Supreme Board Member Duffour thanked everyone for their participation in these strange times, and encouraged their future participation.

State Deputy Duffour thanked the Supreme Board Member for his message and being with us today.

State Chaplain Father Jamin David then provided the State Chaplain report.

Brother Martin extened his appreciation to Father David for his service.

Dan Cabirac, General Insurance Agent, provided the State Insurance Report.

State Secretary Vince Whittington was then called on for the Report of the Credential Committee.

State Secretary Whittington, "In reviewing the list of delegates based on information provided by our councils, and cross checking this with the members that have joined us today for this virtual meeting, our State Treasurer and myself have the following number of delegates:

At this time, we will proceed with the approval of the minutes of the 2020 State Convention which have been distributed prior to the State Convention.

There being no corrections to the minutes, the minutes are approved.

At this time, we will proceed with the Reports of Committees. All Committees met on Saturday, April 24, 2021 via virtual Go-To-Meeting to develop their reports to the State Convention. The Committee Reports have been sent to each State Convention Delegate and have been posted on the Louisiana State Council Website. As the various reports of the committees have been distributed prior to the State Convention, without objection they will be accepted as written and included in the minutes.

Let us move on to the Reports of Officers, As the various reports of the state officers have been distributed prior to the State Convention, without objection they will be accepted as written and included in the minutes.

State Deputy then asked the State Secretary if there was any update to the Credentials Commitee. State Secretary Ducote announced there were no changes.

State Deputy: "Without objection the revised roll of delegates submitted by the Credentials Committee will be the official roll of voting members of the convention.

We will now proceed to the nomination of state officers. Please note that nominations submitted to the State Secretary will be considered as seconded nominations made to the floor for consideration of that respective position."

Voting by the Delegates will occur after the Nomination Process is completed for both State Offices and Supreme Delegates. It is important that voting Delegates follow the instructions on how to vote. The voting will be anonymous. The system that we are using records the votes but does not show how any particular delegate voted.

As a reminder, only credentialed Delegates, have rights to the floor, and you must be recognized to speak. Nominations presented from the floor today will be restricted to the straight forward format of:

ie: 'My name is Joe Delegate, from Council 1234, and I nominate Jim Knight for the position of State Warden.'

Even though we are using an electronic balloting system for the vote, in case of an unforeseen issue, I have appointed David Bakeler, Past State Deputy as the judge and the following Past State Deputies James Riente & Steve Thomas as tellers.

The system that we are using records the votes but does not show how any particular delegate voted.

NOMINATIONS OF SUPREME REPRESENTATIVES

State Deputy: Now let us move into the nominations of the delegates to the Annual Meeting of the Supreme Council.

Before proceeding to the nominations for delegates to the 139th Supreme Convention to be held in Denver, Colorado, August 3-5, 2021, I would like to call on our Worthy State Advocate, Eric R. Miller, to review Resolution Number 9, adopted at the 1997 State Council Meeting in Shreveport. We ask for your individual attention.

State Advocate Miller reviews Resolution Number 9, adopted at the 1997 State Council Meeting in Shreveport, LA.

Your state deputy and the immediate past state deputy are automatic delegates. In addition to these, the Louisiana Jurisdiction can elect {eight (8)} more Third Degree members to represent us at the meeting – four (4) insurance members and four (4) associate members.

At this time, I recognize the State Treasurer Robert Charpentier, Council 9338, for a motion.

State Treasurer Charpentier: I hereby make a motion that ALL nominees for insurance and associate delegates respectively, be hereby accepted also as nominees for ALTERNATE DELEGATES in their respective categories; and be it further moved that after the elected delegates in each category, the next four candidates in descending vote position, in each category be deemed elected as the alternate delegates respectively.

State Deputy Martin: At this time, I recognize the State Warden Richard Yandle for a 2nd to the motion.

Brother Yandle: I second that motion concerning the nomination of Alternate Delegates to the 139th Supreme Convention to be held in Denver, Colorado, August 3-5, 2021.

State Deputy Martin: Be there any Discussion or Objection to the Motion on the Floor, please indicate by utilizing the Hand Raise Feature to be recognized to speak.

Be there no Discussion or Objection to the Motion on the Floor, Without objection, the Motion concerning the nomination of Alternate Delegates to the 139th Supreme Convention to be held in Denver, Colorado, August 3-5, 2021 is hereby approved and accepted.

At this time, we will proceed to the balloting for all State Officer positions, State Deputy, State Secretary, State Treasurer, State Advocate and State Warden; and all delegates to the Annual Meeting of the Supreme Convention, Insurance Delegate and Associate Delegate. Please be advised that the virtual meeting will be paused to enable all delegates to vote. A voting time period of 20 minutes will be allowed for Delegates to cast their votes. Delegates will use the voting links and unique passwords previously provided. Voting will commence at 10:20am and end at 10:40am. The voting platform will be turned off at 10:45am, and no additional votes can be accepted after that time. The Virtual Meeting will resume at 11:00am. Remember to either remain logged in to or log back in to the Virtual Meeting for the election results and to participate in any Runoff elections if required.

The nominations for the following State Officer positions did not have more than one nomination for the position and therefore without objection the state secretary will cast one ballot for George Martin for State Deputy, Vincent Whittington for State Secretary, Robert Charpentier for State Treasurer and Eric Miller for State Advocate for a one-year term commencing July 1, 2021.

All other State Officer Positions and delegates to the Annual Meeting of the Supreme Convention will be elected through the State Convention Delegate voting process.

At this time the Virtual Meeting will be paused until the election process is completed.

The Go-To-Webinar Portal will remain open for any questions concerning access to the Voting Portal. If you have any questions use the Hand Raise Feature and an IT Specialist will respond to your questions

State Deputy Martin: At this time we will reopen the Virtual 2021 Louisiana State Convention Meeting. The ballot has been completed and the tally confirmed. I now call upon the state secretary for the results for State Officers.

State Secretary Whittington: With the total of 125 ballots cast, the majority of the votes went to Richard Yandle who will be our State Warden, for a one-year term commencing July 1, 2021.

State Deputy Martin: The ballot has been completed and the tally confirmed. I now call upon the state secretary for the results for Supreme Delegates.

State Secretary Whittington: With the total of 125 ballots cast, the following individuals received the highest number of votes and will serve as Insurance Delegates: Brett Cormier (123 votes), Mike Rose (101 votes), Tommy Rodrigue (100 votes) and Russell Ruh (89 votes). The remaining nominee, Michael Abbate, received the next highest number of votes for Alternate Insurance Delegate.

With the total of 125 ballots cast, the following individuals received the highest number of votes and will serve as Associate Delegates: Vincent Whittington (95 votes), Robert Lino (86 votes), Michael Rhodes (84 votes) and George Becnel (81 votes). The remaining nominations received next highest number of votes for Alternate Associate Delegate(s) are Ronald Dupuis (78 votes) and Robert Ricca (76 votes).

State Deputy Martin: I ask that all insurance and associate delegates, as well as the alternates for insurance and alternates for associate delegates please email the state secretary your full name, membership #, Council #, date of birth (and phone number), if they have not done so previously. The State Secretary's email address is statesecretary@louisianakc.org Thank you.

At this time, I call on State Advocate to present to us the Report of the Resolutions Committee.

Before he starts, let me state that the recommendation of the resolutions committee will act as an active motion. If anyone wishes to speak on a resolution, please use the Hand Raise Feature, and you will be placed in the queue to speak. Once you are recognized as having the floor, please be ready to speak.

If no one requests to speak, the dropping of the gavel will signal the approval of the committee's recommendation.

State Advocate Eric Miller presents the fourteen (14) resolutions.

All resolutions can be found starting on page forty seven (47).

State Deputy Martin indicates there were no questions or objections and adopts all resolutions.

State Deputy then voiced the need to proceed to New Business.

Under new Business I would like to bring up the review and acceptance of the Budget for the 2020-2021 Louisiana State Council, Knights of Columbus. The Budget and Finance Committee of the 115th Annual Meeting of the Louisiana State Council, Knights of Columbus assembled on April 25, 2020 via a Go-To-Meeting virtual meeting. In accordance with Section 19 Committee on Budget and Finance of the By Laws of the Louisiana State Council, Knights of Columbus, a report is to be developed and presented.

The Budget and Finance Committee Report was developed and distributed to each State Convention Delegate and has been posted on the Louisiana State Council Website. As this report was distributed prior to the State Convention, without objection the report will not be read and will be accepted as written and included in the minutes.

For the purpose of accepting the recommendation of the Budget and Finance Committee to approve the Budget for the 2021-2022 Louisiana State Council, Knights of Columbus, the Chair will entertain a motion.

At this time, I recognize the State Secretary for a motion.

State Secretary Ducote: I hereby make a motion that the Budget for the 2020-2021 Louisiana State Council Knights of Columbus, be accepted and approved as per the report and the recommendation of the Budget and Finance Committee of the 116th Annual Meeting of the Louisiana State Council Knights of Columbus.

State Deputy then recognized State Warden Yandle for a 2nd to the motion.

State Warden Yandle: I second that motion concerning the acceptance and approval of the Budget for the 2021-2022 Louisiana State Council, Knights of Columbus.

State Deputy: Be there any Discussion or Objection to the Motion on the Floor, please indicate by utilizing the Hand Raise Feature to be recognized to speak.

Be there no Discussion or Objection to the Motion on the Floor, Without objection, the Motion concerning the Budget for the 2021-2022 Louisiana State Council Knights of Columbus, be accepted and approved as per the report and recommendation of the Budget and Finance Committee of the 116th Annual Meeting of the Louisiana State Council Knights of Columbus is hereby approved and accepted .

Is there any other business to come before the Convention?

Hearing none, I call on our state chaplain, Fr Jamin David, to lead us in prayer for the Canonization of Father McGivney.

State Chaplain Jamin David: God, our Father, protector of the poor and defender of the widow and orphan, you called your priest, Father Michael J. McGivney, to be an apostle of Christian family life and to lead the young to the generous service of their neighbor. Through the example of his life and virtue may we follow your Son, Jesus Christ, more closely, fulfilling his commandment of charity and building up his Body which is the Church. Let the inspiration of your servant prompt us to greater confidence in your love so that we may continue his work of caring for the needy and the outcast. We humbly ask that you glorify your venerable servant Father Michael J. McGivney on earth according to the design of your holy will. Through his intercession, grant the favor I now present (here make your request). Through Christ our Lord. Amen.

State Deputy Martin: Since there is no other business, the Annual Meeting of the Louisiana State Council is adjourned. I thank everyone for your patience and time today.

State Deputy Report

To the Officers, Delegates, and Members of the 116th Annual Meeting of the Louisiana State Council Knights of Columbus, in accordance with the By-Laws of the Louisiana State Council, I hereby submit my Annual Report for this fraternal year.

Dear, Worthy Supreme Board of Director, State Chaplain, ESO'S, District Master, PSD'S, Diocesan Administrators, District Deputies, State Family, SOA, Grand Knight's, and members,

Although I have only been State Deputy for a more than a month, as of our State Deputy at the time Vernon Ducote stepped down from Office March 8th, 2021, for unforeseen reasons and I was appointed to finish his term for the remainder of the Fraternal year. I will do my best to recap a very unusual year. First and for most we must thank PSD Vernon Ducote for his service during his tenure as State Deputy for guiding us through an exceedingly difficult Fraternal year.

Covid-19 pandemic has stricken us worldwide leaving deadly results and causing everything we have done in our daily routine to change from sanitizing everything we touch, to wearing masks everywhere you go, to shortages on goods we use every day, nursing homes on lockdown, over run hospitals, the State Council canceling many events and using new technology to have meetings through GO TO MEETINGS virtually, and trying to develop a vaccine to fight this pandemic. Thank God for the vaccines to help protect against the spread of this disease, as we try to go back to getting what we have viewed for years as a "normal life". We have seen two positives from this, one, people are turning back to going to God as they are returning to Church gradually and the other is "Leave No Neighbor Behind", which leads everyone to helping Neighbors that they never had time to talk to before, much less assist. These are wonderful things to see and should not stop as we continue to be better Neighbors and better Catholics.

This alone was catastrophic worldwide, but there would be more natural disasters yet for us to face here in Louisiana with hurricanes. We are accustomed to seeing a couple hurricanes in a season, but 5 direct hits and one that skirted by us was extra ordinary. June 5 Cristobal, August 22 Marco and then Laura on the same day, September 13 Sally, September 21 Beta, and October 5 Delta. October 29 Zeta skirted New Orleans and went through Mississippi and Alabama. The devastation was brutal to many regions especially to the Lake Charles Diocese. The Disaster Relief efforts was unified and above and beyond amazing with the outpouring of assistance from Councils and Members across the state to assist their Brothers and Families. General Agent Dustin Dean and his Agency was out assisting in trimming trees and clearing debris from many locations across the Lake Charles and Sulphur areas where needed. Many States sent the Louisiana State Council checks for Disaster Relief, that we are very thankful for. Several Councils spent time collecting supplies to hand out or cooking meals to hand out at Church Parishes or Council Halls like Council 9623 Laplace and Grand Knight Mike Abbatte. State Deputy Vernon and Disaster Relief Director Bill McCrossen spent many hours coordinating with Diocese and Church officials on where to send Councils to help on a daily effort to help those in need. We are thankful for the efforts of Grand Knight Glenn Ray of Broussard Council 7557 for warehousing supplies at his warehouse to collect and disburse and distribute supplies. Vernon and Bill drove from New Orleans and Baton Rouge almost daily to weekly as needed to view where and when the help was needed. This showed the resilience of Louisiana and how we can be self-sufficient and strong enough to go through all this and a pandemic. Many Thanks to everyone who reached out to lend a hand to their neighbor!

State events had to be canceled or changed due to Covid-19 or Hurricanes and with that KCLS had to become Diocese events versus a large gathering. State Deputy, State Secretary, State Membership Director, and a few other key members made every Diocese meeting. The ESO's and Program Director made most but due to other engagements they could not make all of these. Most events were well attended, considering these obstacles listed above.

Grand Knight's Day was also restricted to Diocese meetings because of the restrictions set forth by the parishes and state. Most meetings were better attended than KCLS as members were able to attend with the better changes to restrictions in place.

With everything going on these past few months overall membership stayed in the forefront of our State Officers and Membership Director Richard Yandel. We are still highly ranked Nationally and in the United States staying in the top 10 out of 72 jurisdictions in the world and top 2 in the 50 states. Our focus was to continue to grow the order so the Knights of Columbus can continue to grow our Charitable outreach to our Church Parishes, schools, and community.

Mark Carver has done an excellent job with Programs and communicating to our District Deputies, Grand Knights, and State Family Members during the Fraternal year. The detailed emails that he sends out on a regular basis is truly knowledgeable and helpful to all those who use them.

Stepping into the role of State Deputy has been interesting and fulfilling. Interesting to learn more about the responsibilities of the State Deputy Position and fulfilling the duties as such.

Fulfilling to me is the opportunities of helping Councils in need with assisting them through rough times of transition form a struggling Council to a better/ self-sufficient council. Assisting those that need our support financially like St. Mary's Residential Center, Seminarians, and Pregnancy centers/ Pro Life events.

So far, the most charitable event that has taken place has been the relief effort with the State of Florida/Bahamas. We had 18 pallets of MRE's left over from our disaster relief efforts here in the state and sitting in a warehouse in Broussard. I was able to get some great advice from Supreme Territory Growth Director Jose Jimenez on how we could help another jurisdiction with sharing these with those that are still in need. So, he mentioned that I reached out to Scott O'Conner State Deputy of Florida/Bahamas and I did, and he said he would check with the Archbishop Thomas Wenski who has been working with the Bahamas in relief efforts that are still going on from Hurricane Dorian. Archbishop Thomas was excited this could help quickly as possible. Supreme requested video of the pickup and delivery of pallets to Florida that will be shipped to the Bahamas and interview with Scott and myself for a future video of this "Leave no Neighbor Behind "effort while having Young Knights supporting this effort. Thank you to the Group of Brother Knights that came out to help Glenn Ray to load the eighteen-wheeler headed to Miami. My I interview was in Miami with Scott and a film crew. Video to be released soon and looking forward to seeing the film project. We are so blessed to be able to help others in need either our neighbors in State or neighbors in need in other States.

Per Capita and YEP collections have been obviously hard to collect as Councils are rebounding from the Covid-19 and from Hurricanes during this time period. We are asking if your Council has yet to pay either, please contact me or our State Secretary to make some sort of payment or donation to support the State Council as we try to finish strong and are preparing for the start of the next fraternal year.

State Chaplain Fr. Jamin David has been a great resource and inspiration to the State officers and the State members for his spiritual guidance through the year and continues through his efforts at State Retreat in January, even though the turn out was small, but his outreach to us was outstanding. If you have an opportunity in January to attend, you will not be sorry. Thank you Fr. Jamin!

The State Officers have had a tireless job of handling State Council business from Membership, Programs, Financials, Legal advice, and events. We continue to strive to work hard as your elected officers and as we assist each other to grow the order to bigger and better thing and a brighter future for our fraternal Family across the State. Thank you to Vince Whittington State Secretary, Eric Miller State Advocate, Bobby Charpentier State Warden, and Rennan Duffor IPSDand Board of Director at Supreme!

Special Thanks to Robert Boudreaux our State Administrator as he keeps us up to date on reports, State events, convention proceedings, and many other topics that I probably have not faced yet in this short term as I have been State Deputy.

Our IT Director Brett Cormier has been a great part of our virtual meetings, registrations for events, A/V go to person, and getting us the newest technology to make us more and more the best we can be

by being able to communicate to our members and virtual meetings. Thanks Brett!

State Per-Capita Invoices were mailed to Councils on July 15, 2020 and January 15, 2021. The total amount assessed annually are as follows: Inactive Members \$5.00: Honorary Members- \$5.00: Honorary Members and Disabled Member- no charge: Regular Members- \$8.50

The total Per Capita invoiced this fraternal year: \$184,000.00 minus 25% discount = 23,667.88=\$161069.87. Total collections through June 30, 2021 was 161,069.87. Some councils still owe Per Capita from previous billing cycles; they are included in the list below.

As of this date(twenty-eight) councils have not paid their assessments the total is \$23,000.00. This receivable is as of June 30, 2021.

It should be noted that no council owing money to the State Council or Supreme will be seated at the Annual State Meeting.

All checks were written for the State Council through our server located at the State Office. Quick-Books software is used to work all bookkeeping functions for the State Council. The State Council uses a voucher and receipts system similar to the system used in councils. The State Deputy issues a voucher to authorize checks to be written. The State Secretary then writes the checks, signs and forwards the checks to the State Treasurer who countersigns the checks and mails the checks to the payee.

Serving as your State Secretary has been an honor and a privilege. Visiting councils throughout the state and witnessing the fraternalism and charity has been very humbling, every council has been very gracious to me and I am very grateful for the hospitality.

To our State Deputy Vernon Ducote, thank you for your support and assistance with per capita invoicing, but most of all, thank you for your creativity. You have been a great leader and the success of your efforts is evident throughout the jurisdiction. To my fellow State Treasurer Vince Whittington, State Advocate Eric Miller, and State Warden Bobby Charpentier. State Treasurer Report

To the Officers and Past State Deputies of the Louisiana State Council, Knights of Columbus.

In accordance with Section 7.2 of the by-laws of the Louisiana State Council, all Officers of the State Council shall be required to submit a complete written report to the State Council of their official acts. I am privileged to present the Annual Report of the State Treasurer to my fellow Brother Knights of the Louisiana Jurisdiction for the Fraternal Year 2020-2021

The accounting procedures established for handling the funds of the State Council are sound and have internal controls built into the system. In accordance with Section 9:2 of the by-laws of the Louisiana State Council, the State Secretary shall receive all funds due to the State Council. He shall then prepare a transmittal and deliver the funds and transmittal to the State Treasurer for deposit into the appropriate bank accounts. Referencing Section 10:1 of the by-laws, the State Treasurer is the custodian of all State Council funds and is required to keep a true and accurate record of all funds. In accordance with this, I have done my due diligence in order to comply with our by-laws and I hereby certify that the financial statements presented in this report represents a true and accurate accounting of the financial condition of the Louisiana State Council.

The State Council has two checking accounts that are balanced monthly by the State Treasurer. These accounts are the General Fund Checking and the General Fund Special Checking. Funds are deposited in each of the accounts to facilitate the payment of expenses directly related to each aforementioned account. Additionally, the State Council has an active savings account that is balanced monthly by the State Treasurer. The funds in the savings account is comprised of the trust accounts listed below.

The State Council maintains ten savings/trust accounts: General Fund Trust, YEP Current Trust, YEP Fundraiser Trust, Exemplification Trust, General Fund Unallocated Trust, YEP Unallocated Trust, Louisiana Knights Foundation Trust, Benefit Reserve Trust, Disaster Relief Trust, and Convention Reserve Trust. These accounts are monitored, and reports are given on the earnings or losses monthly. Referencing Section 10:4 of the state council by-laws, the State Treasurer shall segregate and separately account for funds designated as the Youth Expansion Program.

A voucher system is used for all disbursement of funds. The voucher is prepared by the State Deputy and sent to the State Secretary for recording and the production of checks. The State Secretary then forwards the voucher along with the checks to the State Treasurer. An alternative voucher system utilizing the accounting system to enter an electronic voucher to pay bills is done by the State Deputy. The checks are listed as entered and are printed by the State Secretary. The State Treasurer ensures that this activity is recorded in the accounting system of the State Council. Finally, he signs and mails the checks to the appropriate parties. In accordance with Section 8:1 of the state by-laws, all checks issued are required to have the signature of two of the following three State Officers: State Deputy, State Secretary, and State Treasurer.

The State Treasurer ensures the recording of all receipts and expenditures to the financial accounting records are in the appropriate accounts. Each month, he prepares a report of all accounts for review by the State Deputy, Elected State Officers, and Past State Deputies.

Banking accounts are reconciled to the accounting records for the checking, savings, and trust accounts on a monthly basis. The reconciled trust statements are included in the monthly reports to the State Deputy, Elected State Officers, and the Past State Deputies each month.

Budget & Finance Committee Report

To: The Officers and Members of the 116th Annual Meeting of the Louisiana State Council Knights of Columbus assembled on Go-To-Meeting Virtual Meeting. In accordance with Section 19 Committee on Budget and Finance of the By Laws of The Louisiana State Council Knights of Columbus the following report is presented.

In early March, the Elected State Officers and Past State Deputies met to discuss the proposed Budget for the 2021-2022 Columbian year. A copy of the previous year's budget and the income/ expense through December 31, 2020 were furnished to this group in advance, for their preparation for this meeting.

The proposed Budget was submitted to the Elected State Officers and Past State Deputies at the Advisory Board Meeting. The Past State Deputies offered their views and changes or comments that were then incorporated into the proposed Budget.

After this meeting, according to the By-Laws of the State Council, one copy was mailed by the State Office Administrator to all Councils of record.

The Budget and Finance Committee meeting was conducted on Saturday, April 24, on Go-To-Meeting Virtual Meeting at 9:30 AM. This meeting was for the purpose of continuing the review of the proposed Budget.

Included in this review of the proposed Budget for the Louisiana State Council was: General Fund; Youth Expansion Funds; Youth Expansion Fund Raiser, Seminarian Mission Fund Raiser; State Council Office Operations; and Investment Transactions.

By accomplishing this task – the committee on the Budget and Finance has complied with the State Council By-Laws-Section 19-Committee on Budget and Finance.

The Committee took into account that the Proposed Budget carried the approval of the State Deputy and the Elected State Officers. Prior approval was given by the Advisory Board of Past State Deputies at their meeting in March 2021. Based on the review of the Budget and Finances of the State Council, the Budget and Finance Committee offers the following recommendations to you for your considerations here today.

- 1. The Committee recommends that the State Council continue to perform an audit of the funds of the Louisiana State Council by the CPA firm of Thibodaux, Hebert, Deshotels, LeBlanc, LLC.
- 2. The Seminarian Mission Fund should continue to assist with the funding of the Seminarian Mission program.
- 3. Due to the uncertainty of receipts for the 2020-2021 Youth expansion Program Budget. The State Officers, PSD's, and Committee recommends that the following The State Council will Carry-Forward (\$10,000.00) in YEP to help with the short fall of Funds from the local Councils from the 2020-2021 Fraternal Year. We know not all Councils could pay their share to support the YEP Programs, because of Covid-19. The Money Carried -Forward will be used instead of taking out of YEP Unallocated, unless called upon by the State Officers. Then the State will follow the same as below.

If total income for the 2020-2021 Fund Raiser does not equal to the budgeted income, selected Accounts will be decreased with the approval of the Elected State Officers. If funds exceed budget, selected accounts will share in the increased gain with the approval of the Elected State Officers.

- 4. Excess Funds in the General Fund and YEP be placed in existing investment accounts. Any shortfall resulting in the General Fund Budget: funds may be transferred from the General Fund Unallocated (G30.0 General Fund Unallocated) with the concurrence of the State Officers.
- 5. The State Treasurer presented a report of the performance of the Capitol One Bank Trust Group investment account for the Louisiana State Council.

- 6. Since the 2021-2022 Budget was mailed to each Delegate to the State Council Meeting the Budget and Finance Committee recommends discontinuing the line item reading.
- 7. Final Financial Statement as of June 30th, be distributed to each council of record by no later than August 31st of the same year.

Worthy State Deputy – the committee on Budget and Finance moves for the adoption of these line items before concluding this report.

Items 1 – 7 ADOPTION by Committee via Go-To-Meeting, Saturday, April 24, 2021.

The committee agrees that the Budgets for the General Fund, Youth Expansion Fund, Youth Expansion Fund Raiser for 2021-20222, Seminary Mission Fund Raiser for 2020-2021, Exemplification Fund, the Investment Transactions and the State Council Office Operation will be included in the minutes of this State Council Meeting.

Good of the Order Committee Report

To: The Officers and Members of the 116th Annual Meeting of the Louisiana State Council held on Go-To-Meeting Virtual Meeting.

Your committee on the Good of the Order met on Saturday, April 24 at 11:30am, and fully discussed at length the following activity areas. After due deliberation, the committee urges all council, district and state leaders to see that the following recommendations are fully implemented.

The committee would also ask that at future conventions, each member of the Good of the Order Committee, as appointed, be forwarded a copy of the previous year's Good of the Order report to prepare committee members as to what is to be discussed.

FIRST AND FOREMOST WE ARE CATHOLIC

The committee recommends the recitation of the Serran Prayer for Vocations, or another appropriate vocations prayer, at each council meeting and that the council chaplain should encourage the recitation of this prayer at all Masses. The committee further recommends that a prayer be offered at each council meeting for the beatification of our founder Father Michael J. McGivney. The council chaplain should be encouraged to be actively involved in council activities. In the absence of the council Chaplain, a deacon shall be asked to bring the message of our faith. The committee urges all councils to participate in the Refund Support Vocations Program (RSVP). Each council should consider sponsoring a speaker on vocations to the various parochial schools. Recognizing that some clergy may still be apprehensive to Knights of Columbus involvement, the committee recommends each council strongly consider implementation of the Parish Round Table Program and thus show evidence of our belief that VOCATIONS ARE OUR BUSINESS and that each Grand Knight has a dialogue with each Pastor of churches in his council area. Each council should consider having a speaker on evangelization, to encourage each member to promote the Catholic faith to non-Catholics, and to help fallen-away Catholics to become again active in the Church. One way this can be done effectively is by supporting evangelization through the RCIA program. We encourage the State Council to explore the program known as "Calling All Fifth Graders".

PRO-LIFE

The committee recommends increased efforts from the state level to provide more timely and specific information to the council level about upcoming activities such as Pro-Life Rallies. The committee encourages area, district and local Right to Life Masses and demonstrations. It is also recommended that continued active exposure to the public by each council be pursued. (eg. Knights of Columbus prolife plaque in each church parish, small statuary, prolife rose garden, and weekly prolife rosary.) The committee encourages each council to construct a monument to the unborn in a prominent place, preferably on the church grounds and those that have one to maintain and have programs to bring Pro-Life to parishioners attention. We urge right-to-life education, to fight abortion, and specific projects, such as enforcement by members and Grand Knights of letter writing campaigns from council members to state and federal governing bodies. We also urge the use of the vast amount of material that is available about the AIDS Virus, and promoting abstinence and chastity as a way of decreasing the threat of AIDS as well as decreasing abortions and moral decay.

The committee also recommends that councils become involved with local Right-To-Life organizations by way of participating in their events and getting on their mailing lists. The committee urges use of material available to them from the Supreme Council pertaining to Pro-Life. The committee also urges members to fight pornography at the council, family and school levels. The committee further recommends that the State Council provide updated information of current Federal and State legislation on Pro-Life and Euthanasia.

The Committee reommends each council appoints a Pro-Life Chairman or Chair-Couple; supports a youth Pro-Life Retreat as sponsored by the State Council; and offer a Pro-Life prayer at business meetings.

BISHOP GRECO MEMORIAL FUND

The committee recommends that all councils use the memorial cards to memorialize deceased council members. The card can be filled in with the name of the deceased and the name of the donating council. The card is mailed to the member's family. A suggested donation of \$25.00, however any amount is accepted, and sent to the Greco Foundation for the trust fund.

The committee also recommends that councils make a voluntary contribution of \$1.00 per member, on annual basis, to the Bishop Greco Memorial Fund. (The Bishop Greco Memorial Fund can be extended to all Knights and their family members as well as to members of the general public. It is not necessary that one be Catholic to receive Bishop Greco Memorial fund money.)

RETREATS

The committee recommends that each council have a guest speaker with Catholic Retreats as the subject, and schedule retreats for its members, individual as well as couples, encouraging husband and wife retreats

whenever offered.

FAMILY INVOLVEMENT

The committee recommends continual family involvement in council activities. The committee also recommends each council have a monthly Family Communion. The committee strongly recommends that widows of deceased council members be included and recognized in every aspect of the council's life and activity. This committee further recommends that the council members make themselves available to provide assistance to widows and receive a copy of the council news letter and provide transportation if needed.

YOUTH EXPANSION PROGRAM (Y.E.P.)

The committee urges each council to actively support the Youth Expansion Program by annually exceeding it's YEP quota, and by supporting in Catholic youth organizations / activities. The committee recommends that all members in each council be asked to make a personal contribution to our Youth Expansion Program and councils should not depend on fund-raisers only. Each council should consider either making it a part of the dues or adding to their billing a \$10.00 voluntary contribution by each member. The committee recommends that all councils participate in the CYLA Program and that efforts be made to properly recognize the applicants and winners on the council level.

SUBSTANCE ABUSE-HEALTH SERVICES

The committee recommends each council sponsor an educational program on substance abuse by the law enforcement agencies to local junior and senior high schools. The committee urges all Knights to recognize local, state and federal law enforcement agencies. The committee further recommends that councils establish blood donation drives, Cardiopulmonary Resuscitation (CPR) training programs and community blood pressure surveys.

FRATERNAL MEMBERSHIP-NEW COUNCIL DEVELOPMENT

The committee wishes to compliment the former first degree and major degree teams in the Louisiana Jurisdiction for their excellent exemplifications which have acted as catalysts in encouraging all councils to obtain new, active members. The committee wishes to remind all members that it is our Supreme Council's desire that we have a KC presence in every church parish and that we should aid all efforts to form a new council or a Parish Round Table. It is also recommended that all members proposing new members into our Order assume responsibility for insuring the first-degree member receives his major degree as soon as possible, and remains an active member. Also, we would like to thank all councils that have sponsored a first degree team in the past and we strongly recommend that every council make an attempt to establish a new team to conduct the new exemplification of Charity, Unity, and Fraternity, and that all ceremonials be performed with the proper dignity. The committee recom-mends that every council make an effort to bring in new members, but that no less effort be expend-ed to retain the members they now have. Council leaders and members should promote patriotism and encourage members of the third degree to join the fourth degree. Councils should make an effort to support a Columbian Squires Circle which can be a future source of membership and Ladies Auxilia-ry. The committee recommends the promoting of young members and make officers and active members promote young ideas. "Turn over the power". Make the KC's a place for young and old to blend and provide babysitters whenever possible. The committee also recommends that all councils send out bulletins monthly or quarterly, and that copies of the bulletin or newsletter be sent to five councils in the state, on a random basis, for the purpose of spreading and stimulating new ideas. The committee recommends that each council explore the new E-Membership program that is being im-plemented by Supreme Council.

INSURANCE

In view of our Founder Father Michael J. McGivney's purpose to form a Fraternal Benefit Society so that the widows and children of members in the group when the member dies would not find themselves in dire financial straights, Knights of Columbus Insurance was instituted. As the insurance program not only provides this coverage but also helps to finance many of the programs of the Knights of Columbus, we encourage all members to become insurance members, especially State and Council leaders. The committee recommends that all councils have adequate liability insurance as recommended by Supreme.

PROTOCOL

The committee recommends that members of the clergy and Knights of Columbus State Family and officers be properly recognized as to their titles or positions at all Knights of Columbus meetings and functions. Also, we remind members of all the important aspects of protocol as explained in the protocol booklet. The committee also recommends that the State Officers reinstate the policy of visiting subordinate councils and protocol be strictly adhered to.

SERVICE for CAMPAIGN for PEOPLE with INTELLECTUAL DISABILITIES

The Louisiana Knights of Columbus are to be complimented for the tremendous support of the annual statewide fund-raising program benefiting the learning impaired. Each council is called upon to continue this important work and to utilize to the fullest the involvement of families and Ladies Auxiliaries in the fund raising

campaign. The committee recommends that councils use publicity to promote the Knight of Columbus donations by secular and religious newspapers. It is recommended that councils become more involved with activities of the learning impaired citizens at the local level and present the funds to them in a personal manner. The committee also urges councils to actively support the Special Olympics Program, as well as St. Mary's Training Facility in Alexandria.

SUPPORT OF THE ELDERLY AND INFIRMED

The committee urges each council to become actively involved in providing support for the elderly and infirmed citizens of our communities through such activities as weekly or monthly bingos at the retirement or health care facility, also Christmas-Thanksgiving Dinners, sponsoring Masses and communion services at the facility or just plain visitations. The committee also recommends that councils try to promote these programs at all times of the year, not only holidays and special occasions.

SUPPORT OF FOODBANKS AND FEEDING OF THOSE IN NEED

Many people in our communities and across the state and nation struggle through hardships such as pandemics, natural disasters and economic downturn to provide food and other necessities for their families. All councils are therefore encouraged to provide both support and outreach to Catholic charities such as Cross Catholic Outreach, the Knights of Columbus Food for Families, and local foodbanks to promote ongoing food distribution. Councils are also encouraged to donate regularly to both council and state relief funds to assure that funds exist when emergencies arise.

CONCLUSION

The committee urges all councils to implement to the fullest extent, the foregoing recommendations. In order to obtain the fullest implementation of these recommendations, the committee urges the State Deputy to insure that all councils receive and display a copy of this report. As a chairman of the Good of the Order committee, I would like to thank all committee members for their attendance, input, and participation at our meeting Saturday morning. I would also like to thank the State Deputy for the privilege of serving on this committee.

Before the beginning of the fraternal year, the State Deputy asked the State Program Directors to meet at the St Theresa Knights of Columbus In Gonzales.

As the fraternal year was beginning, one of the biggest stories that was continuing to develop that the fact that many Councils was still dealing with the effects of the Covid-19 pandemic. Many Councils was still meeting virtual, and the challenge was to somehow encourage Councils to participate in our Community programs. Those men were no strangers to challenge. The first Knights weathered a great deal of hard-ship, including a pandemic. They courageously laid down their lives by serving others. They tirelessly strengthened their families, parishes and communities. They stood together, as brother Knights. And so did the men who followed in their footsteps, down to our own day.

We are the heirs of this proud tradition. In the beatification of Father McGivney, the Lord has not only confirmed where we have been; he has confirmed where we are going. Our Founder's vision endures in us — and we will carry it forward.

When I look to the future, I see the Knights rising to meet the challenges of our time.

I see us rising in charity, serving those who hunger and hurt, near and far. I see us rising in unity, defending the Church in this difficult time. I see us rising in fraternity, strengthening bonds among our members, while inviting a new generation into our brotherhood.

I see us rising on every front. And I see this, and more, because of what I have already seen.

My view of the Knights was formed as a young man, learning from the example of those around me. I am a third-generation Knight. My grandfather joined in 1915 before he left for World War I. My father, a naval officer, was a faithful member of our parish council until his death. I joined the Order as a college Knight, and I became more involved during my own years in the military and public service

At every stage, I have watched brother Knights put their faith into action. And there is perhaps no better example than the past year.

COVID-19 has been one of the greatest challenges we have ever faced. In a matter of days, our parishes closed, our councils and communities shut down, and our countries ground to a halt. I vividly recall Pope Francis' solitary address in St. Peter's Square in March 2020. Where thousands would have normally stood, the Holy Father stood alone. Where the voices of the faithful would have risen together in prayer, the Holy Father's voice rose alone.

On that day, we saw a Church and a world in crisis. And in the days that followed, the Knights of Columbus confronted that crisis head-on.

We swiftly launched our pandemic initiative, Leave No Neighbor Behind. It ranks among the most successful initiatives in the Order's history. We gave millions of dollars in direct relief and have helped millions of people come through the worst of this crisis.

We supported our brother Knights and their families, helping each other through economic hardships, the loss of loved ones, and the isolation of unprecedented lockdowns.

We supported our parishes, standing beside our priests and helping people safely access the sacraments.

We supported our communities and fed the hungry, providing meals to struggling families and donating to food banks.

We held blood drives in response to severe medical shortages. And through countless quiet and unknown acts of courage, our brother Knights have come alongside their neighbors.

As you gather for your convention, brothers in your jurisdiction and across the Order continue to meet the needs of neighbors, near and far. We recently sent much-needed oxygen and medical supplies to Brazil and Peru, and now we are building an oxygen facility in the region. We will continue to save lives and meet needs worldwide amid the current crisis.

While the pandemic demanded so much of our attention, I am proud to report that brother Knights maintained strong support for all our longstanding and life-changing charitable initiatives.

Through the Global Wheelchair Mission, we have now given more than 100,000 people the gift of mobility.

Through Coats for Kids, we have now kept more than 800,000 vulnerable children warm during winter.

Through our pro-life efforts, including the Ultrasound Initiative and the March for Life, we have saved countless unborn children and assisted mothers to make the courageous choice for life.

In the Middle East, we have helped persecuted Christians reclaim their lives, rebuild their parishes and restore entire towns.

In the wake of earthquakes, hurricanes, floods and wildfires, we have provided food, shelter and medical supplies to families who lost everything.

And thanks to you, in the last fraternal year, we donated more than \$187 million dollars and volunteered more than 77 million hours for charitable causes. As vaccine rollouts promise a return to normal life, I am confident there will be a new outpouring of charity from you and all our brother Knights.

Just as we provide charitable support for our neighbors, we strengthen our families through our insurance program. During the pandemic, we issued more than \$7.3 billion dollars in new insurance. We have now set another record for insurance in force, at more than \$116 billion dollars. Not only does our insurance provide financial security to our Catholic families; it is also an important engine that propels much of our charitable work.

I am grateful to our agents for quickly and successfully adapting to a new, virtual business model. Their hard work enabled our business to come through a very tough year.

I am just as thankful to all our brother Knights for their dedicated service in this time of great challenge. Your witness is in keeping with our highest traditions. You have set the stage for the Order to reach new heights in the days ahead.

As we look to the future, we hope and pray the pandemic will soon be behind us. When that day comes, the Knights of Columbus must lead the restoration of parish and council life. The past year has made clear that the Mass is truly the source and summit of our lives as Catholics. By the same token, we have come to an even deeper appreciation for the bonds of brotherhood forged in our councils. That is why we must devote our strength to fully reopening our parishes and returning to normal council activities as soon as it is safe to do so.

To that end, I am pleased to announce the launch of our "COVID Recovery Plan." Like our Leave No Neighbor Behind initiative, the Recovery Plan offers a high level of customization to fit the needs of your councils and parishes. It will provide concrete ways for you to help restore normal council life and help the men and families of your parishes emerge stronger from this crisis.

I urge you to help your councils adopt the COVID Recovery Plan as soon as possible. The sooner they do, the sooner we will strengthen the Order and the Church, while showing a new generation that the Knights have what men and families need.

One of my top goals in my first year as Supreme Knight is to witness your work and impact firsthand. When travel becomes possible again, I will visit as many jurisdictions as I can. I believe good leadership starts with good listening. So I want to hear and learn from brother Knights in your region and across the world.

I am especially eager to see how you, and all our brother Knights, are helping men grow as husbands and fathers. The men of today are struggling to keep their marriages healthy and their children Catholic amidst an increasingly hostile culture. Men, especially young family men, are looking for help. The Knights of Columbus must be there for them in their crucial vocation as husbands and fathers.

This mission is personal to me, as the father of three young girls. I pledge to focus on new initiatives and resources that will enable you to help the men of your parishes become better husbands and fathers. St. John Paul II affirmed that "the future of humanity passes by way of the family." I believe strongly that the same can be said for the future of the Order.

As we pursue that future, let us turn to St. Joseph for inspiration.

Pope Francis has declared this to be the "Year of St. Joseph." Joseph is the patron saint of fathers, families and the universal Church, and he has a special place in the hearts of Knights everywhere.

In an address to our board of directors, Pope Francis called St. Joseph an "admirable model of those manly virtues of quiet strength, integrity, and fidelity which the Knights of Columbus are committed to preserving, cultivating and passing on to future generations of Catholic men." And in this special year, Pope Francis has said that St. Joseph embodies "creative courage." Creative courage, the Holy Father told us, "emerges especially in the way we deal with difficulties... bring[ing] out resources we did not even think we had."

Given the challenges we face, as a Church and as an Order, every Knight is called to embody St. Joseph's creative courage in the days, months and years ahead. And we should look not only to St. Joseph, but also to our beloved Founder.

Like us, Blessed Michael McGivney lived at a time of difficulty and crisis. The young priest saw urgent problems in his parish and community. He dedicated himself to finding unique solutions. Ultimately, his creative courage led him to found the Knights of Columbus. He knew that in this band of brothers, Catholic men could accomplish great things. Nearly 140 years have proven him correct.

My brothers, we are Father McGivney's heirs. The Knights of Columbus has never been more needed. Our mission has never been more important. The world is crying out for men who look up to God and out for their neighbor. That is who we are, and who we must always be. Let us renew our commitment to charity, unity and fraternity. And in pursuit of those timeless principles, let us muster all the creative courage we can.

May St. Joseph and Blessed Michael McGivney intercede for us. And may the day soon come when I can see you in person and celebrate your good work in service to God and neighbor.
