Re: Fourth Degree Exemplification

On <u>August 15, 2015</u>, the District of Louisiana has scheduled a Fourth Degree Exemplification at Holy Guardian Angels Mission Church, 1701 Bridge City Avenue Bridge City La. 70094. Msgr. Paul J. Richard Assembly #2053 will host the Exemplification.

The Exemplification will be held in the Msgr. J. Anthony Luminais Educational Building located on the grounds of Holy Guardian Angels Mission Church 1701 Bridge City Avenue, Bridge City, LA. Registration will be from 9:00 A M to 11:00 A M in the Educational Building (Signs will be posted). The banquet will begin at 11:15 A M. The Exemplification will follow, beginning promptly at 1:30 P M and conclude at approximately 3:30 P M. The Vigil Mass will be at 4:00 P M in the Church.

The Exemplification cost for candidates is \$70.00, which includes their banquet meal, Social Baldric and Fourth Degree Lapel Pin.

The cost of the banquet for all Sir Knights, their spouses, candidate's spouses and guests will be **\$20.00**. Reservations must be made with the Master with the forms provided no later than *August 5, 2015*. <u>Any</u> request for banquet tickets received after the deadline cannot be guaranteed.

As a reminder, the **official dress** code for all candidates and Sir Knights **for all Fourth Degree** Exemplifications is black tuxedo, *plain white pleated tuxedo shirt with lay down collar*, black bow tie, black cummerbund, black socks and black shoes. This is a must, *NO EXCEPTIONS* except priest and military. Visiting Sir Knights will wear their social baldric with their attire. The only exceptions are clergy, deacons in clerics if allowed and candidates presently enlisted in military service who may wear their **FULL** dress uniform.

All registration forms and Form 4 (<u>must be filled out completely</u>) for candidates for this Exemplification and <u>must</u> be received no later than <u>August 5, 2015</u>. Checks should be made payable to: <u>Master's Fund</u>, one check for all candidates from the assembly. Forward only the <u>Supreme</u> Secretary's and the Master's copy of the Form 4 with the checks.

For proper arrangements for meals and check-in, it is imperative that we keep to the deadline. Any registration after this date cannot guarantee the candidate's name in the program or that a certificate can be presented to him at the ceremony.
