Since 2003, each September has been designated as Life Insurance Awareness Month. Like most awareness-raising campaigns, Life Insurance Awareness Month was created because there is an overwhelming lack of understanding of the product among the general public. Each year, the Life Insurance Market Research Association puts out the results from a recent survey, and unfortunately, the numbers they report continue to be discouraging.

A recent survey found that 76 percent of people polled did not have a personal financial advisor. Sixty-eight percent of that same survey group said their opinion of the current economic conditions was somewhat unfavorable or very unfavorable.

In other words, a majority of those surveyed were uncomfortable with the economy and the uncertainty it brings, yet they did not seek professional assistance. Maybe they spoke with their friends and family. Maybe they hoped the instability would go away on its own. Maybe they did not know to whom to turn.

Marquette is giving away \$500.

Marquette has \$500 to give away to two deserving students. A 250 word essay could result in a \$250 scholarship for a child's education.

The annual *Rudy Classen Memorial Scholarship* will be awarded once again this Spring. Two \$250.00 scholarships are awarded as a memorial to a great Knight—the late Rudolph “Rudy” Classen.

The criteria for receiving this scholarship are as follows:

(1) All students going from a Catholic school into a Catholic high school (8th or 9th grade) are eligible.

(2) A 250 word essay entitled “*What my Catholic education means to me*” will be reviewed by the committee consisting of the Chaplain, Grand Knight and Chancellor. Should a conflict of interest occur, or at the request of one of the committee members, the Chaplain will appoint a Marquette member in good standing as a substitute.

(3) Essays are to be presented no later than the September general meeting to the Deputy Grand Knight. In the event of multiple entries, the Deputy Grand Knight will code the entries to assure anonymity, before presenting the essays to the Grand Knight. Should there be a conflict of interest involving the Deputy Grand Knight then a trustee will be appointed to collect the essays.

(4) The scholarships will be awarded at the Fall Quarterly communion, date and location to be determined by the Church Director and Chaplain.

Race Ends In Huge Controversy

Home and Building Improvement Association

What follows is an explanation of the relationship between the Marquette Council, The Marquette Home Building and Improvement Association Inc., and the Board of Directors of that latter organization.

As the Supreme By-Laws forbid any Knights of Columbus Council to own real estate; the Marquette Home Building and Improvement Association Inc. was incorporated August 1, 1956 for the sole purpose of obtaining and maintaining a permanent home for the Marquette Council 1437. This organization's members consist of all members of the Marquette Council in good standing, while only Third Degree members have the right to vote and hold office. The sole beneficiary for any and all funds received is the Marquette Council.

The Board of Directors for the Home Building and Improvement Association (hereafter referred to as the Board) is an elected board of 11 members – 9 who are elected on a staggered three year term with 3 member terms expiring annually. The other 2 members are on the Board via their elected positions as Grand Knight and Immediate Past Grand Knight.

The Board handles all of the activities in leasing the available space to our tenant, collects rent and handles all structural repairs on the building (312-314 St Charles, New Orleans) and remits any remaining funds less 10% for a major repair fund) to the Council – no individual or organization other than the Marquette Council can benefit from the Boards activities.

The 11 Board members meet twice a year – in January to elect their officers for the term, review all expenses and budget for anticipated maintenance and repairs. In August the, month prior to the annual Corporation meeting, the insurance is reviewed; building value established and another review of all past and anticipated repairs are reviewed.

The Annual Corporation meeting is held in September at the Marquette Council home just prior to the scheduled Marquette monthly business meeting on the 2nd Wednesday of the month. At this meeting all third degree members in good standing are invited to run for the 3 elected positions and to then vote on the members who terms are expiring. The elected members will be elected for a three year term and will be eligible to be considered for an officer position on the Board.

As every Third Degree member in good standing is a voting member of the Marquette Home Building and Improvement Association Inc., they have the right to know whatever business is being conducted on their behalf. The only exception would be the terms of the lease agreement with the tenant as that has privacy issues with our tenant.

If there is any member in good standing desires to know anything about the board, please feel free to contact any board member. The Board is the guiding directors for the corporation duly elected by the membership to conduct business for the betterment of all Marquette members of any degree, as laid out in their by-laws and articles of incorporation. ♦
