Common LTC misconceptions

As Baby Boomers have reached retirement years, long-term care (LTC) insurance products have gotten more public attention, but they're still not well understood, especially when it comes to how to pay for care.

For example, many Americans believe that Medicare pays for long-term assistance with the basic activities of daily living — but it doesn't. It applies only to those who have been in the hospital 72 hours and are diagnosed as requiring "skilled care." Medicaid covers care only if and when the person has gone through a "spend down" and has no other means to pay for it. Not a good situation to be in.

Another common issue is that Boomers think they can wait to buy LTC. Unfortunately, this could be a financial devastating choice. What happens if you suddenly become ill or uninsurable before you have made this purchase? Again, not a good situation.



Waiting to buy will also increase the cost of the premiums you pay. Consider this example. If you buy a Knights of Columbus Comprehensive Long-Term Care policy for yourself with a \$200 daily benefit, lifetime benefit duration and 30day elimination period at age 40, your annual premium will be \$739.20. The total premium paid by age 85 will be \$33,264. If you decide to wait to buy the same policy until you are 60 years old, your annual premium will be \$2,374 and the total premium paid by age 85 will be \$59,350. That's a difference of more than \$26,000. (This example is for comparison purposes only.)

Personal service is crucial in choosing LTC policy options, and for adjusting them as necessary. Group LTC may indeed be a viable option for you, but as your Knights of Columbus agent, I can help you compare the details so you can make an informed decision.

40 Days for Life update:

The campaign runs from September 28th through November 6th. Day 31, 410 babies saved.

Today's 40 Days For Life story is not one you'd hear every day.

Two years ago this month, former Planned Parenthood director Abby Johnson experienced a conversion after witnessing a live abortion on an ultrasound at her office in Texas.

She walked into my office at the Coalition for Life next door, told me her story, then resigned from the abortion industry.



I had known Abby for eight years before that day and I'd had multiple conversations with her through the fence outside Planned Parenthood. But after her conversion, I realized how much I didn't know.

I didn't know that her parents were prolife and had been praying for her to leave Planned Parenthood.

I didn't know her husband was pro-life and her job created tension in their family.

I didn't know that before Abby saw that ultrasound, even she was starting to see that Planned Parenthood cares more about abortion than anything else.

We don't know what God is doing behind the scenes. We must trust, we must pray — and we must know that our witness on the sidewalk is always part of a larger picture.

Here's a story that shows what I mean. I'm not revealing names and locations, and I've changed some details. This is still a work in progress!

THE ABORTIONIST'S WIFE

A vigil participant was noticing that nearly all the cars in the abortion center parking lot were parked in the staff area — very few were in the area reserved for those with appointments. And that was good.

The volunteer was soon deep in prayer when the abortionist drove up — with his wife and their teenager. He got out of the car and headed toward the

building while the wife and teen drove away.

The abortionist's wife pulled up next to the vigil participant, rolled down her window and asked, "How are you doing?" The surprised volunteer answered, "Good! How about you?" She responded, "I just wanted to tell you that I so appreciate what you do and how you are always so nice and respectful." That simple response turned out to be the opening line in a very lengthy conversation.

The wife expressed her gratitude for the way the 40 Days for Life vigil is conducted. In another city, there is a group outside the abortion center that yells at her husband.

Here, however, he's been told that the vigil participants are praying for him. "He just can't understand how you can be so against what he does and yet so nice to him."

She explained that her husband grew up in a home that had no use for religion — the concept is totally foreign to him. The volunteer promised to pray that he would be able to grasp — and eventually embrace — faith. The teen blurted out, "Please do!"

"I asked the abortionist's wife to pray for me," said the volunteer, "and she said she would."

The wife said, "I'm really impressed that you believe in something so strongly and passionately that you're willing to be here every week for years in every kind of weather"




"There is much to meditate upon from this conversation," said the 40 Days for Life volunteer. "It confirmed the constant presence, the peaceful method, the prayerful attitude. It helped give me a renewed sense of dedication to continually trying to get people to sign up so that we can have a constant presence on the sidewalk. We never know who will see us and when they will see us.

"God gave me an awesome story in order to ask once again for you to join us for 40 Days for Life. Please keep praying for an end to abortion and for ALL those involved. God is using us to help bring His children to Him — ALL of them!"

Listed are just a few of the benefits associated with becoming a Knight of Columbus.

Life Insurance program – Offers member, spouse and children the opportunity to provide for their security and well-being. Rated AAA (Superior) by Standard & Poor's and A++ (Superior) by A.M. Best (for 35 years).

Annuity Program – Enables member and spouse to provide for retirement and build an estate through tax-deferred savings.(3% life time guarantee)

Long Term Care Insurance – Enables members and their spouses to safeguard their assets and afford the care and assistance needed later in life

New Member Annuity plan – Non-Qualified fixed rate annuity offered to new members in their first year after joining the order. Can be started with as little as \$100, and offers a guarantee rate of 3% return.

Additional Member Benefits offered to insured members

Widow Benefits;

Continues to be covered under the Member/Spouse Fraternal Benefit (Accidental Death)

Eligible to purchase Life insurance, annuities, or Long Term Care up to *1 year* after insured members death.(IF MEMBER WAS INSURED) Will receive a free lifetime subscription to Columbia Magazine

Continues to be eligible with her children for all scholarships.

Family Fraternal Benefit (For Eligible Families)

To be eligible the member or spouse must own a small permanent life insurance policy, with a minimum of \$150 annual premium. The brother knight must also be in good standing with his council.

Pays \$1,500 for the child who dies before the age of 61 days

Pays \$750 for the child who is stillborn at least 20 weeks after conception

Offers guaranteed-issue insurance up to \$5,000 to any child under age 18

Offered at standard rates for uninsurable children, provided application is made before child is 61 days old.

Offered at a rated premium for uninsurable children between ages of 61 days old and 18 years.



Up to \$5,000 at standard rates for a mentally impaired child, otherwise in good health, between the ages of 3 years and 18 years.

Eligibility for the guaranteed-issue benefit (#3), also requires that the child's brothers and sisters, who have not been denied for insurance, must be insured under an individual Knights of Columbus certificate.

Orphan Fraternal Benefit Program (Same eligibility as with Family Fraternal Benefit)

\$80 benefit is paid monthly to each orphaned child until age 19, graduates from high school, enters military service, marries, discontinues Knights of Columbus insurance, or no longer attends school unless disabled.

If the orphan attends college or vocational/technical school full-time, the benefit can continue to age 23!

The child may also be eligible for up to \$1,750 each year in educational grants. The grants are based on financial need and will not exceed a maximum of \$7,000 over a 4 year period.
