INSURANCE UPDATE

Raising awareness about life insurance

Each September since 2003 has been Life designated as Insurance Awareness Month. Like most awareness-raising campaigns, Life Awareness Month Insurance was created because there is an overwhelming lack of understanding of the product among the general public. Each year, the Life Insurance Market Research Association (LIMRA) puts out the results from a recent survey, and unfortunately, the numbers they report continue to be discouraging.

A recent survey found that more than 75 percent of people polled did not have a personal financial advisor. Sixty-eight percent of that same survey group said their opinion of the current economic conditions was somewhat unfavorable or very unfavorable.

In other words, a majority of those surveyed were uncomfortable with the economy and the uncertainty it brings, yet they did not seek professional assistance. Maybe they spoke with their friends and family. Maybe they hoped the instability would go away on its own. Maybe they did not know to whom to turn.

If you fall into this category, please remember that as a member of the Knights of Columbus, you have a fulltime, professional agent you can call your own. My primary responsibility is the care and service of your family's life insurance, retirement and long-term care needs. I'll answer your questions because I want your decisions to be informed ones. I want to help.

Another LIMRA statistic said 43 percent of people did not buy life insurance because they worry about "making the wrong decision." Talk with me agent, and, afterwards, you'll understand that the only wrong decision was not purchasing sooner to protect your family's future.

The Father Michael J. McGivney Guild serves as a source of information about the life, works and spirituality of Father McGivney, our founder. The Guild distributes information materials about him, receives reports of favors granted through his intercession and oversees the distribution of relics. There are more than 132,000 members of the Father McGivney Guild.

The purpose of the Guild is to inspire greater personal holiness and cooperation with God's grace bv disseminating information about Father "The Guild's goal is to McGivnev. spread the good word about Father McGivney's holiness of life. to encourage devotion in his memory and seek his intercession before the throne of God." said Dominican Father Gabriel B. O'Donnell, quild director and postulator of father McGivney's cause for canonization.

The Knights of Columbus founded the Guild in 1997 concurrently with the archdiocesan phase of Father McGivney's cause for canonization. Membership in the Guild, which is free, is open to all individuals and households. but not to groups. Members of the Knights of Columbus are not automatically Guild members and must elect to join the Guild. The Father Michael J. McGivney Guild Newsletter is published bimonthly except July-August, and is free to Guild members.

Culture of Life Update

Brothers, I would like to share a correspondence from our State Culture of Life Chair Couple that I think you will find inspiring.

Please follow the attached link to the Life News Website for a very inspiring article. It seems that the biological mother of this year's Auburn University Homecoming Queen was raped two decades ago and became pregnant. A married woman, this mother was given two choices by her husband, divorce or abortion. Though the choice meant the break up of her marriage, with assistance from an organization much like those we support with our Baby Bottle Campaigns, she instead chose to carry the baby full term. She gave birth rather than have an abortion and her child was adopted by a loving family.

Today the child, Miss Molly Anne Dutton and many of her friends are celebrating a victory on campus and making Molly's story known as Pro-Life advocates, through a campaign to raise funding for *Lifeline Children's Services*, an Alabama Christian Adoption organization. This was the same organization that helped Molly's mother some twenty-two years ago.

A subject we often avoid, abortion following rape is thought to be the best choice by the majority; however, studies of women who have had abortions have determined that abortion in the case of rape is not the "best choice" for the mother. Rather than releasing her from the trauma of the rape, in many cases the abortion acts as a second trauma to a woman who has been sexually assaulted. In contrast, those that give birth do not feel violated twice as some would lead you to believe.

There are several studies and articles that have been written on the subject of rape, incest and abortion. One that we found to be very informative was by David Reardon of the Elliot Institute*. If there is any doubt in your mind that abortion is not the best "choice" even in cases of rape & incest, you may find this article mind changing. You may also be surprised to find out that abortion is actually <u>not</u> chosen by rape victims in a majority of cases (about 75%).

According to the studies, women do not want to undergo another act of violence by having an abortion. * - (NOTE: The Elliot Institute website is a very good resource for "post abortion issues".
